A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MARYED MUSIC SPORTS ZONE FOR THE SUPPLY & DELIVERY OF VARIOUS SPORTS MATERIALS FOR THE TRAINING IN PREPARATION FOR THE PALARONG BICOL 2024

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-04-0342** with an Approved Budget for the Contract (ABC) of **Php 400,000.00**;
