A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO COTTON CITY MARKETING CORP. FOR THE SUPPLY & DELIVERY OF CARGO PANTS FOR TRAFFIC UNIFORM OF TMU PERSONNEL
