A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFE DINER & CATERING SERVICES FOR THE MEALS & VENUE FOR THE TRAINING ON ACCREDITATION AND MOBILIZATION OF COMMUNITY-DISASTER VOLUNTEERS FOR DISASTER RESPONSE

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-06-0710** with an Approved Budget for the Contract (ABC) of **Php 115,500.00**;
