A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE JO-LABOR & MATERIALS FOR THE FABRICATION AND INSTALLATION - MAINTENANCE OF CITY PLAZA AT CITY PROPER, TABACO CITY
