**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR THE JO-LABOR, EQUIPMENT RENTAL AND MATERIALS FOR THE OPERATION AND MAINTENANCE OF FARM TO MARKET ROAD HACIENDA TO VISITA SECTION AT SAN MIGUEL ISLAND, TABACO CITY**
