A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE JO-LABOR & MATERIALS FOR THE REPAIR / IMPROVEMENT OF CITY LIBRARY AT CITY LIBRARY, CITY MALL, TABACO CITY
