A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE JO-SUPPLY OF LABOR, MATERIALS, AND EQUIPMENT FOR THE CONSTRUCTION OF ANIMAL SHELTER AT SAN ANTONIO EVACUATION CENTER, BRGY. SAN ANTONIO, TABACO CITY
