A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO GUBAT ST. ANTHONY COOPERATIVE FOR THE SUPPLY & DELIVERY OF FRESH CARABAO'S MILK FOR FEEDING SUPPLEMENTATION FOR UNDERNOURISHED CHILDREN

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-07-0914** with an Approved Budget for the Contract (ABC) of **Php 468,000.00**;
