A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EBB CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF VARIOUS MATERIALS FOR DISHWASHING STARTER KIT AND RAG MAKING FOR LIVELIHOOD SKILLS TRAINING
