A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARIZAPA WELDING SHOP FOR THE JO-LABOR & MATERIALS FOR THE IMPROVEMENT OF YOUTH HOME ISOLATION ROOM AT BRGY. OSON, TABACO CITY
