A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO XIAN SCHOOL AND OFFICE SUPPLIES DEPOT FOR THE SUPPLY & DELIVERY OF VARIOUS SUPPLIES FOR SECRETARIAT IN PREPARATION FOR THE PALARONG BICOL 2024
