A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VEHICLE PARTS AND LUBRICANTS FOR VEHICLES WITH PLATE NO./CONDUCTION STICKER JM-4520, S3E-788 AND F1D-840
