A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LUCKY IVORY NON-SPECIALIZED WHOLESALE TRADING FOR THE SUPPLY & DELIVERY OF NUTRITIONAL MILK FOR FEEDING SUPPLEMENTATION FOR UNDERNOURISHED PWD CHILDREN AGES 24-59 MONTHS
