A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PLC TRADING INC. FOR THE SUPPLY & DELIVERY OF INFANT WEIGHING SCALE WITH HEIGHT BOARD FOR NUTRITION ADVOCACY PROGRAM 2024
