#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MARVZ AUTO CARE SERVICES FOR THE VEHICLE REPAIR & MAINTENANCE OF GARBAGE TRUCK WITH PLATE NO. SAB-4935 OF CENRO
