**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SCL POZO NEGRO EXCAVATOR AND PLUMBING SERVICES FOR THE JOB ORDER- SIPHONING OF SEPTIC TANK SLUDGE AT SAN ANTONIO LYING-IN**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-08-1009** with an Approved Budget for the Contract (ABC) of **Php 96,000.00**;

**WHEREAS**, the BAC has sent at least three (3) Request for Quotation for this procurement to suppliers, contractors or consultants of known qualifications, namely SCL Pozo Negro Excavator and Plumbing Services, Klean Care Enterprises, and RDM Anbalka Enterprises;

**WHEREAS**, after the deadline for submission of price quotations, the BAC received only one (1) Price Quotation from SCL Pozo Negro Excavator and Plumbing Services;

**WHEREAS**, according to the guidelines for Small Value Procurement receipt of at least one (1) quotation is sufficient to proceed with the evaluation. Thus, upon opening of the single Price Quotation, the result was as follows
