A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO AYEN GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF BUNTIS AND BABY STARTER KIT FOR PROMOTION OF BREASTFEEDING AND PROMOTION OF COMPLEMENTARY FOODS (BUNTIS CONGRESS)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request No. 24-08-1123 with an Approved Budget for the Contract (ABC) of Php 124,800.00;
