A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO POWER PRIME CAR SERVICE CENTER FOR THE SUPPLY & DELIVERY OF VARIOUS TIRES AND FLAPS AND TUBES FOR THE VARIOUS TRANSPORTATION EQUIPMENT AND HEAVY EQUIPMENT OWNED BY THE CITY GOVERNMENT OF TABACO

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-09-1214** with an Approved Budget for the Contract (ABC) of **Php 591,648.00**;
