**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CPQ COMPUTER CENTER FOR THE SUPPLY & DELIVERY OF VARIOUS IT SUPPLIES FOR THE TRAINING FOR COMPUTER SYSTEM SERVICING (CSS) NC-II COURSE FOR 1ST QUARTER**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-03-0231** with an Approved Budget for the Contract (ABC) of **Php 91,870.00**;

**WHEREAS**, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

**WHEREAS**, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Pixel8 Web Solutions & Consultancy Inc. was found to be non-compliant with the requirements of the project, particularly the brand of the offered items. Pixel8 Web Solutions & Consultancy Inc. failed to indicate the brand of its offered item, hence its bid was disqualified;

**WHEREAS**, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, CPQ Computer Center, and its bid was found to be responsive with the requirements of the project;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To award the contract to **CPQ COMPUTER CENTER** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b) To recommend to the City Mayor of Tabaco the award of contract to **CPQ COMPUTER CENTER** in the amount of **Eighty Nine Thousand Six Hundred Pesos (Php 89,600.00)**.
