A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JYQ ENTERPRISES FOR THE JO-LABOR & MATERIALS FOR THE REPAIR OF VEHICLE WITH PLATE NO. / CONDUCTION STICKERS SJH-118 AND D2C-830

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-06-0706** with an Approved Budget for the Contract (ABC) of **Php 67,193.40**;
