A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JYQ ENTERPRISES FOR THE JO-LABOR & MATERIALS FOR THE REPAIR & MAINTENANCE OF VEHICLE WITH PLATE NO. / CONDUCTION STICKERS SEH-685 AND SJX-677
