**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF GROWING UP MILK FOR FEEDING SUPPLEMENTATION FOR UNDERNOURISHED CHILDREN 24-59 MONTHS OLD**
