A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PRECIOUSTAR CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF VARIOUS OTHER AND JANITORIAL SUPPLIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request No. 24-08-1015 with an Approved Budget for the Contract (ABC) of Php 367,420.00;
