**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To award the contract to **4KMB General Merchandise** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
