**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VITAMINS A FORTIFIED OIL AND IODIZED SALT FOR PROMOTION OF FORTIFIED FOOD PRODUCTS**
