A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EDIELYN MAE AGRI AND FEEDS SUPPLY FOR THE SUPPLY & DELIVERY OF BIOFERTILIZER TO BE DISTRIBUTED TO RICE FARMERS
