A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KR MIKA GEN. MDSE. FOR THE SUPPLY & DELIVERY OF RAINBOOTS FOR OPERATION AND MAINTENANCE WORKS OF CENRO PERSONNEL (GARBAGE COLLECTORS, STREET SWEEPERS, CENTRAL MRF AND SANITARY LANDFILL)

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


