A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JOUIR GEN. MDSE. FOR THE SUPPLY & DELIVERY OF SCUBA DIVING GEAR AND ACCESSORIES FOR CAO AT SAGURONG MARINE SANCTUARY AND OTHER DIVING AREA
