A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAROLYN A HOTEL & RESTAURANT FOR THE MEALS & VENUE FOR THE PROMOTION OF BREASTFEEDING AND PROMOTION OF COMPLEMENTARY FOODS (BUNTIS CONGRESS)
