A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GENERAL MDSE. FOR THE SUPPLY & DELIVERY OF DRUGS AND MEDICINES FOR BUNTIS DAY MOBILE CARAVAN DRUGS AND MEDICINES SUPPLIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-08-1145** with an Approved Budget for the Contract (ABC) of **Php 149,970.00**;
