### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 BISTRO CATERING SERVICES FOR THE MEALS FOR THE LIVELIHOOD SKILLS TRAINING FOR SOLO PARENTS
