A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFE DINER & CATERING SERVICES FOR THE MEALS & VENUE FOR THE 2 DAY ADVOCACY FORUM ON HIV-AIDS PREVENTION AND ORIENTATION ON SOGIE BILL
