A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KR MIKA GEN. MDSE. FOR THE SUPPLY & DELIVERY OF VARIOUS FOOD INGREDIENTS FOR FEEDING SUPPLEMENTATION FOR UNDERNOURISHED CHILDREN
