A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EL PALACIO DIOCESAN PASTORAL DEVELOPMENT ORG. INC. FOR THE ROOM ACCOMMODATION WITH MEALS AND VENUE FOR THE 2 DAYS CAPACITY BUILDING FOR LCPC MEMBERS
