A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE JO-SUPPLY OF LABOR, MATERIALS AND EQUIPMENT RENTAL FOR THE FABRICATION OF OFFICE TABLES, CABINETS AND CONFERENCE TABLE AT CENR OFFICE, BRGY. SAN VICENTE, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Small Value Procurement under Section 53.9 of the IRR-RA 9184 as the mode of procurement for Purchase Request No. 24-09-1184 with an Approved Budget for the Contract (ABC) of Php 362,000.00;
