A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GENERAL MDSE. FOR THE SUPPLY & DELIVERY OF HOSPITAL BEDS FOR ISOLATED AND SICK PDLS AT THE ISOLATION FACILITY – HEALTH AND SANITATION PROGRAM FOR PDLS
