A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DNC LIGHTS & SOUNDS RENTAL FOR THE RENTAL OF SOUNDS AND LIGHTS WITH LED WALL AND BACK-UP GENERATOR FOR "SEARCH FOR MISS ISLAND FESTIVAL QUEEN 2024"
