**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFE DINER & CATERING SERVICES FOR THE MEALS FOR THE PRODUCTION TRAINING RE: AN ANTI-PLASTIC AND SOLID WASTE MANAGEMENT INFORMATION AND EDUCATION CAMPAIGN**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-09-1288** with an Approved Budget for the Contract (ABC) of **Php 225,000.00**;
