A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO THEISM FOOD HOUSE FOR THE MEALS FOR THE CAMPAIGN AND ADVOCACY ON THE III-EFFECTS OF ILLEGAL DRUG

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-09-1295** with an Approved Budget for the Contract (ABC) of **Php 246,000.00**;
