A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE JO-LABOR & MATERIALS FOR THE CONSTRUCTION AND INSTALLATION OF 15 UNITS SOLAR STREETLIGHTS GOING TO CENTRAL MRF SAN VICENTE, TABACO CITY
