A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE JO-LABOR & MATERIALS, FABRICATION OF OFFICE TABLES AT MAYON ELEMENTARY SCHOOL, TABACO CITY
