A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 BISTRO CATERING SERVICES FOR THE MEALS & VENUE FOR THE TRAINING ON RELAPSE PREVENTION FOR PERSONS WHO USED DRUGS
