A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO REY AUDIO ACTIVE PRO LIGHTS & SOUNDS FOR THE RENTAL OF LIGHTS AND SOUNDS FOR THE YOUTH CONGRESS 2.0: CAPITALIZING / HARNESSING THE YOUTH FOR NATION - BUILDING
