A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KR MIKA GEN. MDSE. FOR THE SUPPLY & DELIVERY OF ZEOLITE AND CHLORINE FOR SANITARY LANDFILL AND CENTRAL MRF OPERATION AND MAINTENANCE TO NEUTRALIZE ODOR AND PURIFIES WATER
