**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE MAINTENANCE WORK AT HIRAYA MANAWARI NATURE PARK AND FACILITIES, SAN VICENTE, TABACO CITY**
