A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MARVZ AUTOCARE SERVICES FOR THE JO-LABOR & MATERIALS FOR THE GENERAL REPAIR OF DUMP TRUCK WITH PLATE NO. SAB-5049 OF CENRO
