WHEREAS, the BAC directly invited **TABACO AMERICAN GROCERY, INC.** to submit a bid proposal for the foregoing project;


WHEREAS, **TABACO AMERICAN GROCERY, INC.** is a supplier with technical, legal and financial capability to supply and deliver the required goods;
