A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VARIOUS PARTS AND ACCESSORIES FOR THE REPAIR OF THE PATROL BOAT AND SERVICE VEHICLE WITH PLATE NO. SJX-677
