A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE JO-LABOR & MATERIALS FOR THE ELECTRICAL WIRING RESTORATION / MAINTENANCE OF 4TH FLOOR, PAGCOR BLDG. AT TNHS CAMPUS, TABACO CITY
