**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SAN CARLOS HARDWARE, OPC FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE SUPPLIES FOR THE REPAIR AND MAINTENANCE OF CITY ROADS, ALONG VARIOUS CITY ROADS, TABACO CITY**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-09-1255** with an Approved Budget for the Contract (ABC) of **Php 85,291.00**;
